## Player Development (Amy, Sonja, Dani)

- Pitching lessons
  - Currently don't have space due to dome collapse; Strike Zone unable to accommodate for 3/15
  - Sonja's sister will be providing training on 3/15
  - Pitching lessons go through 3/29
- In-season pitching instruction
  - \$125-150/hour
  - Discussion around dividing up by age groups for instruction
  - Consider charging a fee to offset cost
- Strike Zone summer camp early registration for Rosemount players; now open to all

#### Director Discussion (Amber)

- Assessment discussion
  - 6 players attended Burnsville evaluations due to conflicts with Rosemount assessments
  - Inconsistencies with players attending different tryouts (different metrics used/not used)
  - Consider weeknight tryouts
  - Consider completing assessments and making teams in fall
    - Danielle willing to take the lead to make a proposal
    - 10u/12u/14u would try out in August, similar to other club teams or October (immediately after fall ball)
    - Team would be set for the year/summer teams could enter winter/spring dome tournaments

- 1 team per level = club like experience
- Would need to determine uniforms, registration, payments, what's included and expected
- Coach Ranking voting
  - All coaches that were interviewed left the room
  - Coaching committees presented their rankings for coaches
  - Board voted to approve rankings for 8u, 10u, 12u, and 14u coaches
- Discussion around level of play for teams
  - Per bylaws, C teams should be equal/even
  - Based on metrics, 10u Team 6 scores were 20+ points below Team 5, therefore Team 5 will be a B level team
- Bylaw considerations
  - Head coach discussion multiple coaches wanting to be head coach of two teams
    - Discussion around allowing head and assistant coach positions, but not being head coach of 2 teams
  - Clarification on sibling rule
  - Define the evaluation committee for team formation
  - Coaches viewing assessments
  - If not coach selected/available at time of team selection, board voted to interview the recommended and/or coach that agrees to step into the head coach role
